

FLAGSTAFF IN MOTION




Flagstaff in Motion is a 5-year plan that will address how to best provide and fund Mountain Line transit services. Amongst the key outcomes will be a prioritized list of service growth scenarios to support the region's current and future transit needs.

Stride Forward will incorporate and build on the recommendations from Flagstaff in Motion and provide guidance for the future beyond the next five-years.

FLAGSTAFF ACTIVE TRANSPORTATION MASTER PLAN (ATMP)



The City of Flagstaff is working on an Active Transportation Master Plan (ATMP) to serve as a detailed guide to enhancing walking and biking in Flagstaff. This master plan will make specific recommendations for strategies, actions, projects, and programs. It is tentatively scheduled for City Council adoption in March 2022.

Stride Forward will identify ATMP projects' influence on travel behavior.

FLAGSTAFF CARBON NEUTRALITY PLAN



The Carbon Neutrality Plan establishes a vision for how Flagstaff will create a carbon-neutral future. Achieving this goal will require reducing our greenhouse gas emissions through drastic shifts in how we heat our buildings, travel from place to place, and dispose of waste. Policy support for the plan was amended into the Flagstaff Regional Plan on December 7, 2021.

Stride Forward will assess different land use and transportation projects and strategies that influence the effect of transportation on climate.

CITY OF FLAGSTAFF REGIONAL PLAN



The Flagstaff Regional Plan, updated every 10-years, is a policy guide for the same area MetroPlan serves. It is the City of Flagstaff general plan and an amendment to the Coconino County Comprehensive Plan.

As mandated by state law, the plan covers a range of topics including transportation. The Transportation Element policies are the basis for MetroPlan's *Blueprint 2040*. A major update to the regional plan is starting in 2022.

Stride Forward's policies resulting from evaluation of Onward and Upward will provide valuable information to the regional plan update.
